158/21/FC Apologies

Apologies had been received from Cllr Lawrence due to the change in meeting date and Cllr Trevethan due to illness.

159/21/FC Declarations of Interest and Dispensations Granted

Cllr Bowers declared an interest on item 16a, grant application request from Perranporth AFC and would abstain from a vote.

160/21/FC Minutes of Last Meeting

Subject to minor amendments, the minutes of the last meetings held on the 13th September were AGREED as a true and accurate record.

161/21/FC Cornwall Councillors' Report

Cllr Harvey reported that Cornwall Council has been named the nation's leading local authority in tackling the climate crisis in a prestigious awards ceremony. The unitary authority has won the Leadership in Responding to the Climate Emergency category in the MJ Local Government Achievement Awards .

163/21/FC Update on Street Marshalls

Cllr Bowers shared an update regarding the street marshalls and their work to date.
The Council received an update following a recent police liaison meeting

164/21/FC Update on matters relating to the Watering Hole and the clean-up of the beach and surrounding areas

Following on from the letters of complaints received from members of the public and concerns from

councillors regarding the rubbish and mess outside the back of the Watering Hole, Cllr Bowers, Cllr Byfield and Simon Dowling met with the Watering Hole management on site. The area has been cleaned up substantially and plans will be made for extra storage to avoid the appearance of clutter. The management of the area would need to be closely monitored going forward.

165/21/FC Note accounts and approve payment schedule for September

The accounts and payment schedule for September were approved.

166/21/FC Christmas Comes to Perranporth Initiative

Cllr Pentecost informed members of growing plans for a 'Christmas comes to Perranporth' Initiative, which would see all the shops in the high-street open into the evening on Friday's running up to Christmas. Members gave support to the initiative.

Members noted a report from Perranporth Library manager – Linda Jones

168/21/FC Review of policies

Members reviewed the previously adopted Publication Scheme Policy and Perranporth Emergency Flood plan and AGREED that no amendments were required. Members AGREED to adopt the Safeguarding Policy for the Library.

169/21/FC Purchase of 10 large trees

Members AGREED to a proposal to purchase a number of trees up to the value of £3000. Locations to be confirmed.

170/21/FC Lease Saints Trail Land to Cornwall Council

Members AGREED to lease a small section of land to Cornwall Council as part of the Saints Trail.
Action: Confirm that Cornwall Council would cover the Parish Council's legal fees. Request a draft agreement for approval at a Full Council meeting considering appropriate clauses – Finance Officer

172/21/FC Security Method to the Inner Green

The post that secured the gate to the inner green had been damaged beyond repair. A replacement post would need to be removable to allow access for larger vehicles.

Action: Investigate the whereabouts of the damaged post – Cllr Arthur

173/21/FC Grant Applications

Perranporth AFC –. Members AGREED to defer the grant decision until the potential of applying for S106 funds had been investigated.

Seiners Arms –Members AGREED to turn down the grant application as they do not feel it is in the best interests of the whole community.
