Proposal: Demolition of the outside garden kitchen and the erection of a two

**Response:** Object (unanimous) on the grounds that the proposal represents overdevelopment, would be unneighbourly, there were contradictions in the Design and Access Statement, poor disabled access, the construction didn't have planning consent and there were concerns regarding the 150 year old retaining wall.

**Response:** Object (unanimous) on the grounds that the proposal represents development in the countryside and would not contribute to the required housing need. We maintain our objections, as Cornwall Council did previously, on this site.

Proposal: Self-contained annexe to provide living accommodation and to be

rentable on short term lettings as holiday accommodation

Location: 6 Lower Hillcrest Perranporth Cornwall TR6 0JZ

**Response:** Object (unanimous) on the grounds that the proposal would be detrimental to the character of the area, would extend beyond the building line, would be unneighbourly, the parking provision would be inadequate with insufficient turning area and there would also be loss of shrubs, trees and habitat.
