# 007/23/PC Apologies

Apologies for absence had been received from Councillor Lawrence and the reason was accepted by members.

## 008/23/PC Declarations of interest and dispensations granted

Councillor Linda Higgins declared an interest in item e) PA23/00228 and took no part in the discussion. No dispensations had been granted.

# 010/23/PC Considerations of planning applications

The following applications were considered and proposals agreed:

# a) Application PA22/11139

Application for permission in principle: proposed demolition and
residential development (between 5-9 units)
St Georges Country Hotel St Georges Hill Perranporth
Cornwall
Mr and Mrs Harris

**Response:** Object (1 abstention) as the proposal would represent development in the countryside and it was considered that Perranporth should not lose another hotel. It was considered that the Hotel should be listed as was 180 years old and that the historic value and heritage should be taken into account. The property belonged to a former Captain of a Tin Mine and was part of the mining heritage within a heritage site. The proposal would also have a negative impact on nature conservation and the character of the area.

### b) Application PA22/02896

- Proposal: Associated leisure facilities through redevelopment and refurbishment along with landscaping, boundary treatment, access, parking, drainage, services and plant. The application is accompanied by an Environmental Statement.
- Location: Penhale Camp Camp Road Holywell Bay Newquay Cornwall TR8 5PF

**Response:** Object (unanimous) for the following reasons:

The large developments would have a cumulative, negative, impact on nature conservation and would be within an area of great landscape value in close proximity to the SAC and SSSI. The developments would put pressure on the infrastructure including education and the NHS.

The increased traffic would have a detrimental effect on highway safety due to the access along a narrow single carriageway.
