Response: Object (2 abstentions): Though the NDP had not been adopted, it had

reached stage 16 and could be taken into consideration. There had been a history of noise disturbance, caused by amplified music, having an adverse impact on the amenity of residents. The proposal would affect the quiet enjoyment of the Area of Outstanding Natural Beauty and Heritage Coast and was considered to be feature/scope creep with a background of a series of applications on this site gradually extending the intensity and types of

development and use.
