# Minutes of the meeting held on Monday 23 October 2023 at 6.00pm in the Council Chamber, Chyanhale, Ponsmere Valley, Perranporth, TR6 0DB

**Public Participation:** 16 members of the public attended. 3 members of the public spoke against application PA23/07959, Bolingey Fishing Lake, Penwartha Road, Bolingey and 1 spoke in support of the application. 1 member of the public spoke against application PA23/05878, Land South of Butterclip Road, Reen Cross Road, Goonhavern and an agent spoke in support of the application.

In addition to this, Tourism policies TO1 and TO2 would not support the siting of new

holiday accommodation on previously undeveloped land.
